Re: Notice of Public Hearing- 26 & 28 Undermountain Road

Dear Neighbor,

There will be a Planning & Zoning Commission public hearing on our special permit application for 26 & 28 Undermountain Road on June 3, 2024 at 6:45pm via zoom. The Zoom link is below and the full agenda will be posted on the town's website.

We are applying for a special permit to construct two single family homes at this site. We have proposed two site plan layout options in our application. Option 1 would retain the public parking area on Undermountain Road, the two single family homes would be built in the middle of the parcel and a smaller open space would be retained at the rear of the property. Option 2 would eliminate the parking area, the homes would be built closer to the road and a larger open space would be retained in the back of the parcel. Copies of these site plans can be found on the town's website and at Town Hall.

These new homes will be sold at an affordable cost to a family earning less than 80% of the area median income. The Salisbury Housing Trust will retain ownership of the land under the homes through a ground lease arrangement, as we do for all the homes we build or renovate. In this way, we assure that the home will be affordable for the first homeowner and to future homeowners as well.


