The proposed Generator location would have no impact on the wetlands because no excavation is required we would set a pre cast pad on the existing crushed stone and the Lp gas connection would be run along the trim of the building to the existing Lp gas regulator.

The electrical connections would be run directly into the building also.

If we relocate the generator trenching would be required from the Lp gas regulator or tank to the generator that is in the wetlands set back now along with the electrical connections.
