- 3. Approval of Minutes of July 3, 2024 (Special Meeting) Tabled

- 5. Wood Turtle Correspondences Discussion

L. Potter talked about a memo from Michael Klemens, which included the protection of Wood Turtle habitats using 3 zones of precautions. M. Todaro explained that the memo was for informational purposes. L. Potter would like to invite Mr. Klemens to the next meeting to discuss the subject further; M. Todaro will contact him to schedule.
