

Thank you for your comments which I reviewed with our Land Use Director. We were able to successfully address and integrate some of your concerns, but we would ask your assistance in providing us with a copy of the 2014 Pathways Strategic Plan. We searched on-line Town documents and reviewed your minutes of 2014 and 2015 and even beyond. While there is a lot of discussion of various proposed projects and ideas in those minutes, we couldn't find a specific consolidated strategic plan that we can refer to and cite in the POCD.
