Good evening, Attorney Murphy:

Land Use Office staff forwarded you inquiry to me. I believe we met some time ago at your house on Undermountain Road with Cristin Rich.

I am glad you asked the question as it is indeed a confusing topic to many people.

PZC members are elected by the citizens of Salisbury to discharge functions enabled by State statutes and local regulations.

While members of the public are free to contact their elected members of the Planning and Zoning Commission on matters that are not before the Commission, once we open a hearing on an application the decision makers need to be free of influences outside of the public hearing/meeting/deliberation process.

This is difficult to achieve in a small community, but we do our best to not interact with friends and neighbors on the merits of an application we are hearing or deliberating on. We ask that all communications are sent to the Land Use Office where they become part of the public record. We ask the public not to email, call, or contact individual commissioners but use the public hearing process to express their concerns.

If such a contact is made to an individual commissioner during that process, they must disclose this for the record.

The closest analogy that I can make is when a jury deliberates on a case, they must not be influenced by outside sources during that period which could prejudice their vote.

Our goal is run a fair and impartial process where everyone receives equal treatment and complete transparency. The public often fails to understand this--particularly on controversial matters.

When needed we seek advice from the Commission's legal counsel. Commissioners are required by State statute to receive periodic training to remain current in our understanding of the law. This coming March many of us will be attending an all-day training session with the Land Use Section of the Connecticut Bar Association.

Under separate cover I will send an article I wrote for the Lakeville Journal trying to clarify and distinguish our role from other elected and appointed officials.

I sincerely hope that this provides the clarification you need.

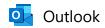



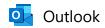

Dear Neighbors,

John and I are residents of 75 Sharon Rd and have loved every part of this beautiful community, one that we hope to see maintained and cared for. We're writing out of concern for the proposed expansion of the Wake Robin Inn. We were not part of the initial notification which is why we felt the importance to reach out and ensure that everyone on the lake was aware of what this entailed.

In short, the developers are proposing:

- expansion of the existing inn which includes an addition of 12 cottages on the property going from 38 to 70 rooms, the Inn will have a restaurant and gym
- a pool and pool bar (approx 5,000 sq ft)
- a significant parking lot across from the inn and a smaller parking lot along Wells Hill with a suggested use of the great lawn as an overspill for parking

• an event space - a total of 12,000 sq ft - of which 4,500 sq ft will be used for events which will accommodate up to 200 people and can go as late as 2 a.m. on Fridays and Saturdays. The event barn will also have a casual outdoor dining space.

With this, comes many environmental and safety issues, some of which are:

- significant increase in traffic (which also equates to more noise) including blind turns on both Wells Hill and Sharon Rd
- sound and light pollution from events, parking lots and lighting around the property
- town sewer capacity is at risk which can impact our lake
- the removal of hundreds of trees

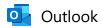
