Thank you for your work on this.

Please find attached the Application Floor Plan Drawing with a proposed kitchen for the owner's unit in the existing dining room.

I have also included a floorplan of the existing 2nd floor bedroom and bathroom that are and always have been in this home and are fully reflected in the tax records. The Field Card shows it as: Building Sub-Areas (sq ft) "EAF Attic, Expansion, Finished 1,020 (gross) 561 (finished)".

I have absolutely no desire (or funding!) to add another bedroom. I do not see it as even a fantasy in the foreseeable future. I am downsizing, not upsizing. The is absolutely no hidden agenda and I only say that because I am sure that you deal with it all the time.
