JANUARY 7, 2025 – 9:00AM (HYBRID)

- 1. Call to Order. Present: Carol Mason, Heidi Hoeller, M.C. Taylor and Howard Sobel. Absent: Arek Feredjian (Alternate).
- 2. **Approval of the Agenda. So Moved** by H. Hoeller, seconded by M.C. Taylor and unanimously **Approved.**
- 3. Approval of the Minutes of November 12, 2024. C. Mason and H. Hoeller commented that it should be noted that the Zoom option was not available at that meeting; H. Hoeller and A. Feredjian tried to phone in, but were unable to join the meeting via Zoom. A Motion to Approve the Minutes of November 12, 2024, as amended, was made by H. Hoeller, seconded by M.C. Taylor and unanimously Approved.
- 4. COA #2024-015 / Congregational Church / 30 Main Street / Create Handicap Access Ramp to the Main Street Entrance / DOR: 12/10/2024 Pastor John Nelson, Angela Lomanto, Joe Lesch (Architect), were present to represent the application. Mr. Lesch described the project details and renderings. C. Mason asked if the front stairs would be eliminated; Mr. Lesch answered no. H. Hoeller commented that the ramp would connect to the side door to the right of the main entrance; Mr. Lesch described the current situation and added that there would be no outside railing on the proposed ramp. C. Mason and H. Hoeller commented that it is a nice design and they like it. H. Sobel commented that it is elegant and functional; a great plan. H. Hoeller asked if railings were required for the ramp; Mr. Lesch answered no, they aren't necessary. Mr. Lesch offered that they are also planning on extending the sidewalk to the curb for handicapped parking, but that is not part of this application. M. C. Taylor asked where the ramp would be in relation to the EV chargers; Mr. Lesch answered that the parking spaces would be further away towards Main Street. C. Mason asked if the handrails at the front steps would stay; Mr. Lesch answered they would not be changed. A Motion to Accept COA #2024-015 was made by H. Sobel, seconded by H. - 8. Discussion: Finalization of the COA form. C. Mason noted that once the COA is final, it will be used for on-line applications on the new HDC page of the Town website. In addition, information from the current Historic Salisbury page will be transferred, as well an updated version of the Guide and the map.
- 9. Discussion: Pamphlet Review Follow-up. C. Mason suggested waiting for the link to the new webpage and the map to be ready, before a final draft of the Guide is completed. H. Sobel commented that the Guide needs to have the same information as the COA. C. Mason pointed out that the new Guide, along with a letter to Historic District homeowners will go out together. H. Sobel will coordinate the information going into the Guide.
