## **BOS – Minutes – 2.3.2025**

The Board of Selectmen Regular Meeting minutes of February 3, 2025.

**Present:** Curtis Rand, First Selectman; Christian Williams, Selectman; Katherine Kiefer, Selectman; members of the press and public.

The meeting was **called to order** at 5:00pm.

K. Kiefer made a motion to **approve the agenda**. C. Williams seconded, and the motion was approved unanimously.

C. Williams made a motion to **approve the minutes of the January 6,th, 2025 Regular Meeting**. K. Kiefer seconded, and the motion was approved unanimously.

### **First Selectman Report**

C. Rand reminded everyone of the Annual Town Meeting, which will be held on Wednesday, February 5, 2025 at 7:30pm.

C. Rand gave a brief update on the situation with solid waste transportation and the dissolution of Materials Innovation and Recycling Authority (MIRA) timeline. The Northwest Council of Governments continues to work on this in close affiliation with their attorneys, the board from MIRA and the state.

Tighe & Bond is still working on evaluating the sewer plant for capacity for possible developments.

### **New Business**

- a. The Town is working on applying for a Small Town Economic Assistance Program (STEAP) grant. Possible use of the grant funding would for rehabilitation of the multi-use courts and fencing at Trotta Field, fixing the acoustics in the Senior Center building by installing sound-absorbing panels and resurfacing the playground at the Town Grove.
- b. K. Kiefer made a motion to authorize Curtis Rand, First Selectman to enter into and execute any and all agreements, contracts and documents necessary to obtain the neglected Cemetery Account Grant should the town be selected for a grant award. C. Williams seconded, and the motion was approved unanimously.
- c. **Appointments**
  - C. Williams made a motion to appoint Kevin Cantele to fill the vacancy on the Salisbury Affordable Housing Commission. K. Kiefer seconded, and the motion was approved unanimously.
  - C. Williams made a motion to appoint Lou Bucceri as the Town Historian. K. Kiefer seconded, and the motion was approved unanimously.

### **Selectmen's Reports**

C. Williams encouraged people to sign up for the town newsletter to see events happening in the town.

K. Kiefer mentioned she attended the Northwest CT Economic Development Symposium, Pathways to Progress in January. The event was for Professional Development and Networking opportunities to support local and regional Economic Development goals in Northwest CT.
